# How can I save money this Tax Season?

Our simplest tax filing service for those that want a professional tax return done on time. It's a flat fee of \$295 and includes one state return electronically filed without appointment, advice, or commentary - just a tax return.

People with the following can't do Bronze level: Landlords, farmers, business owners (small or big), international income or assets, as well as multi-state.

This level is 85% of our clients. They want Bronze with the face-time, advice, and review. At this level the pricing does vary by professional and complexity. For example, a landlord would pay about \$85 per rental property more than someone without. This service starts at \$495 and will average around \$650-\$700.

This is Silver plus ongoing communication ability and a tax plan review/analysis. These clients typically are (non -incorporated) small business owners who need more help with something. We do a mid-year to late 3<sup>rd</sup> quarter analysis to forecast tax outcome, provide tax planning, open enrollment planning, and will not charge for questions during the year. These people tend to spend around \$1500+ a year.

# MN PTE Payment by December 31st

As you may (or may not know) on your personal, you are limited to \$10000 of S.A.L.T deduction on your Schedule A. Basically, that means when you pay real estate taxes on your home, vehicle license tabs and MN Income taxes, you are capped at \$10000. You probably pay a lot of MN taxes and get no federal deduction benefit. It is a double tax!

Minnesota finally did something to benefit S corporations and Partnerships and created an entity level tax. This is a tax paid by the company and not you personally. Once the company pays this tax (cash filers) or accrues tax (accrual filers) you will get a federal deduction at the entity level (i.e. this reduces your federal taxable K-1!). Then, every penny you paid at the entity level is given to shareholders as a pre-paid tax at their percentage of ownership on their personal tax return. If you own 100%, then you get it all.

#### So, two important take-a-ways:

- (1) Every dollar gets credited to personal returns
- (2) You get to reduce your federal taxable income by your share of the PTE tax.

### Congrats, you have bypassed the S.A.L.T. limitation of \$10000!

# FAQ:

*How much do I pay?* You will pay exactly 9.85% of your profit calculated before adding the PTE tax deduction.

How do I Pay it? You must login to MN E Services and pay it through your online business account. This is not an Individual income tax. Please review the attached PDF on how to make that payment.

When is it Due? This tax is due 3/15 and Not 4/15 like normal income tax *How much will I save doing this?* You will save an amount equal to your margin tax rate on the federal return times the amount you pay for PTE. (i.e. 24% bracket saves 24% of the PTE payment)

### **Inflation Reduction Act** of 2022

On August 16, 2022 the "Inflation Reduction Act of 2022" was signed into law by President Biden. One of the provisions of this legislation that received a significant amount of media attention was the additional \$79.6 billion in funding to the Internal Revenue Service (IRS). While the republicans fought against this and will try to undo it, there is little they can do in the future.

It is important to understand what this means to you. There is no way to know exactly how this will impact US taxpayers, it is safe to say there will be an exponential amount of Federal tax audits in the coming years. From my perspective doing tax work for 25 years, I have seen less than 10 federal tax audits over that time. When such a lack of oversight occurs, I have noticed clients, year-after-year becoming more aggressive in tax write offs and less focused on documentation to prove the write-off is legitimate.

My job is to provide wisdom and to help clients not learn the hard way. It is imperative that we all sharpen up our documentation procedures for the future. I am talking about 3rd party receipts; those little pieces of paper that will fade over time. If you are taking tax deductions, you must have accurate proof and logs to support the positions. Categorize them by month, by vendor - have them digitally scanned, or stored in a shoe box - just have them. When you use your vehicle for work, make sure you have a proper log to support the deduction. As tax accountants, it's not our job to ask for proof, but we do want to keep our clients from trouble. If I was to tell you that you will have the most stressful and expensive financial audit of your life in three years but it is preventable by acting today, would that be enough motivation to change?

Make sure you talk with your tax advisor about it. Audits are coming folks, and they are coming in a big way. Accept the wisdom, make changes to your paperwork situation
