Medium Business \$499.99/y*. Reasons you might want to stick with QB Desktop is if you have multiple businesses. If you have fewer than 3 users, do a lot of invoicing and would benefit from mobile app, among other benefits, QBO could be for you. Plus, by going through us, you'll be paying less than you would on your own.

Tax Planning for 2023!

How to be ready for your Tax Planning appointment?



As much as we want the summer to stay, Tax Planning season (and Fall!) is right around the corner! This year we will be opening the season on October 1st.

Our goal in this meeting is to forecast your business tax return outcome at least 6 months in advance, so you can budget, plan, and prepare accordingly. Doing so we can also discuss how to improve that outcome, going over retirement plans, tax law changes and asset acquisitions.

We will also have the opportunity to discuss open enrollment questions related to Health Insurance and HSA accounts, as well as Year End Reporting timelines for closing and 1099s.

How do you prepare for this meeting? To benefit most from the tax planning, first, you want to make sure your books are up to date and reconciled. Second, you want

to have a really good idea of what the final numbers for the rest of the year will be. If your business varies too much in the last quarter, we want to meet you closer to the end of the year, if your numbers are pretty consistent year-round, we'd like to meet you sooner! Third, you want to allow yourself around 1.5 – 2 hours for this appointment, so we can carefully go over everything.

If you are on Engagement with us and you have Tax Planning included, you will automatically get scheduled and notified, no additional charge.

If you are <u>not</u> on engagement or don't have this option included, the fee is \$900 for 2hrs. Note that there tends to be a return on investment that greatly surpasses this amount, with the knowledge and strategical planning involved. However, it remains your choice! Call us to get on the schedule!


